Not enough information. He thinks is a very small change. Several Councillors felt this application should be resubmitted with clearer information.

This area is currently fenced off as the front garden of the Farm. It is not clear if the farm has agreed to this plan. The

Discussion re: suitability of the houses/building materials proposed for this rural location are not local vernacular. It was pointed out that there is no such thing as Contemporary Countryside Vernacular and that these houses do not conform to or chime with the vernacular of this part of South Somerset. Discussion re: lack of affordable houses in this application. Concerns re: sites entrance & exit onto the busy main road although the visibility is good here. Concerns that PV panels should definitely be fitted – they are marked as potential for pv panels.</p>
